Peace and Social Concerns Committee Report

Peace & Social Concerns met on Sunday, January 29, 2017.

Attending: Pam Wood; Jane Alexandre; Richard Schmidt; Kathy Stackhouse; June Tano; Constance Benson; Brian D'Agostino; Corona Machemer (acting as clerk)

On January 15, instead of our regular Peace & Social Concerns meeting, Morningsiders held an Amnesty International Write for Rights event. Thanks to Naomi Paz Greenberg, who had prepared all the materials before going into the hospital for surgery, including drafts of letters to officials that Friends could sign, we sent a total of 75 letters to officials in support of individuals (and one group) in 10 countries. Thirteen hand-written personal letters were sent to individuals. In addition, Friends took home letters to send by email to President Obama supporting clemency for Chelsea Manning, Edward Snowden, and Leonard Peltier (a Native American leader who was sentenced to life in prison for the murder two FBI agents in 1975 during the Wounded Knee incident at the Pine Ridge Reservation in South Dakota; many, including Amnesty International, believe he was railroaded).

At the meeting on the 29th:

- 1. Friends hear a presentation by Brian D'Agostino about his "Proposal for a Green New Deal." Brian asks Friends' help in building a coalition of groups to generate a movement to implement Green New Deal policies, which he and colleagues have developed, relating to an agenda of massive public investment in renewable energy, infrastructure, and other public works that create sustainable, productive jobs. For more, see Brian's book, *Manufacturing Green Prosperity: The Power to Rebuild the American Middle Class*, a copy of which he has donated to the Morningside library.
 - Friends offer suggestions on how to begin; most stress that movements with staying power generally start small and local, with local concerns and/or projects that demonstrate the principles at work. If innovative projects that fill the bill already exist, then a first step might be a conference bringing the innovators together to explore the implementation of policies that will further the development of their projects and similar ones through political action. It is suggested that Brian develop a concept paper to state more clearly what he means by "Green New Deal," in order to frame the policy agenda laid in the Proposal. It is also suggested that he get in touch with Quaker Earthcare Witness network, both through New York Yearly Meeting and the local Friends in Unity with Nature committee (Tom Goodridge is Morningside's liaison).
- 2. On February 12, in place of the regularly scheduled P&SC meeting, Christine Ashley, Field Secretary for the Friends Committee on National Legislation (FCNL) will lead a workshop from 1:00 to 3:00 pm, following Meeting for Worship, on "next steps" in the Age of Trump. We intend to invite people from Riverside and from other New York Meetings. Christine describes the event this way: We'll have an opportunity to learn, strategize and plan the next steps to take: how we Friends can make our views heard and influence members of Congress and other government change agents on issues important to Quakers.
- 3. The Peace & Social Concerns budget for 2017 is discussed. The total budgeted by the Meeting is \$12,800 (the same as last year). There are a few questions remaining, so the budget is not being presented with this report. The Committee has chosen not to allocate the entire budget, and as of this writing, \$550 remains in the new "P&SC Reserve Fund for Emergencies."
- 4. The next regular meeting of Peace & Social Concerns will take place on February 19 at 1:00 pm.

Communications Committee Report

Continuing its focus on the new Address Register, the committee further updated the database, incorporating information provided by Ministry & Counsel, which has been reviewing the current list to make sure only those who are truly part of our community are included. The Committee also continues to enter in the database contact information provided by newcomers in the Red Book. Because there are still questions to be answered and people to be contacted,

the new Register is not quite ready to go to press. The Committee compiled a list of those in the database whom Ministry & Counsel noted should be contacted; this list has been forwarded to M&C. We also made a list of those with missing or unclear information, and these people will be contacted by Kathy Stackhouse, who has taken on the job of database manager.

Going forward, Friends may update their profiles by entering the new information (a new email address, for example) in the Redbook (write "update" on the entry).

Friends may also update their profiles directly in the database. Instructions for editing (updating) your profile are available on the Help page of the website. (If you have trouble logging in to the website, use the "Contact" tab on the website to contact Bryan Oettel; include his name in the subject line of your query. You are especially likely to have trouble if you have recently changed your email address, because your old one was your default user name when the database was set up.)

The Committee is concerned that Friends are not visiting/using the Website as much as we had hoped. As a way to encourage more "traffic," we have decided to open the Bulletin Board up to all visitors to the site, the same way that all visitors may access the calendar. As with the calendar, only logged-in members may post notices to the Bulletin Board. But Friends (and others) will no longer have go through the process of logging in to see what's up on the Bulletin Board.

Friends are reminded to visit the website (www.morningsidemeeting.org) regularly (daily?!) to check the Calendar and to view the Bulletin Board (for the moment you still have to log in to do this). Instructions on using these two "community building" features of the website are available on the "Help" page of the website.

For the month of January 2017, we received \$782 in contributions and interest. And we disbursed \$463 (representing a \$200 cash advance to hospitality, \$260 for childcare, \$27 for breakfasts and \$17 for the library. Additionally, we made a \$1,100 deposit for our October retreat.

The unrestricted bank operating balance at 1/31/17, net of checks issued but not yet paid, was \$38,438. The Finance Committee anticipates that letters confirming donations of \$250 or more for tax purposes will be mailed the middle of February.
