Report from Meeting with Children - May 2013

The Meeting with Children is flourishing. Children have come every First Day this year with the exception of Easter and when we had the retreat. Usually only one or two have come, but twice we had three and once there were four. There were adults available every week. Last year from January through May we had only had one time that children came as opposed to 16 times so far this year. It confirms that advice "Build it and they will come".

We continue to gather on the 8th floor a little while before 11:00 having brought down the colorful striped rug and the two bean bag chairs, blocks, books, crayons, and other toys ready for whatever children may come. The coat rack is still a favorite toy as well. If too many adults appear we decide which two will stay. If no children appear by 11:15 the two can go up to meeting but are ready in case any children do come later.

Now that the weather is better we've been able to go out into the park twice. On the first visit Alicia found an abandoned pickaxe and thanks to Patricia we were able to get it back to the Riverside Park volunteers who sent Alicia a thank you note. On the second trip the water fountain was the focus of attention which was quite different from the one we've played with on the 8th floor. From those experiences we came up with a phrase to describe what we are doing, "Exploring together as friends".

Anyone who might be interested is welcome to come see the 8th floor with its delightful balcony overlooking the Hudson and to watch younger and older folks having a peaceful, joyful time just being together.

As many as 100 detainees are on hunger strike.

Some are being force fed through thick and painful tubes.

While 80 have been cleared for release, no funding is available for their transport because of the reduction in the military budget.

The mistreatment of Korans during searches continues.

Friends approve organizing postcard signing for the following week.

Sally agrees to print up postcards and bring stamps for the following week at Morningside Meeting.

Naomi agrees to print up postcards to make them available during Quarterly Meeting at 15th St.

Further information is available below.

- 2. Naomi reports that the Flushing Interfaith Council is proceeding with A Second Flushing Remonstrance, but that the final text has not yet been discerned.
- 3. Naomi reports briefly on the International Conference on War Tax Resistance and Peace Tax Campaigns in Colombia, explaining that a full report is currently being edited.

Dear President Obama:

I am grateful for your efforts to restore U.S. leadership on human rights issues and in particular your executive order halting U.S. torture of detainees. I am also grateful that you committed to closing the prison at Guantanamo Bay and that you reiterated that commitment shortly before you were re-elected.

You have suggested that Congress is to blame for putting in place restrictions that make it difficult to close Guantanamo. I agree with your understanding about the role of Congress, but I note that late last year, you signed the FY 2013 National Defense Authorization Act—legislation that extends those restrictions for another year.

I know that there were probably other important programs in this legislation, but I urge you now to either figure out how to work within the restrictions put in place by Congress to close Guantanamo, or to veto any legislation containing those restrictions in the future. If you do not, then Guantanamo will outlast your presidency. That would be a terrible legacy. Thank you again for your commitment to human rights and to closing Guantanamo.

Our year to date income of \$4,477 is 13% of our total budget and is just 69% of the year to date income last year. At 4/30/13, we have disbursed \$1,210 more than we have received.

The financial report for April records \$1,351 in receipts and \$605 in disbursements for the month (\$400 P&SC allocation to The Catholic Worker, plus Scholarship relief and plus charges for the newsletter and breakfast, flowing through to \$746 in excess of receipts over disbursements). An appeal letter is being prepared for distribution in early May.
